Towards A Sustainable Fundraising Model for Think Tanks in the CEE Region

One of the key organisational challenges think tanks in the CEE region face today is that of fundraising or ensuring sufficient amount of funding to secure the continuation of research and related activities. The shortage of both public and private resources available is exacerbated by the relative underdevelopment of public-private partnerships, incentives for the private sector to engage with non-profit organizations, and increasingly rigid regulatory system. As a result, many think tanks and NGOs compete for the same restricted pool of funding available and their activities are restrained and at risk. It is also important that think tanks are not overly reliant on one institutional or private donor but have sufficiently diversified donor portfolio in order to avoid risking decrease in their independence or face public scepticism. Against the background of growing distrust towards experts and inward-looking political scene across the region, balancing domestic and foreign sources of funding is another increasingly pressing challenge. How can think tanks in CEE overcome this crucial obstacle and ensure continuation of their work? How can think tanks become sustainable and what are the successful models of fundraising for CEE think tanks? What are the current successful models of fundraising?
